

Policy on personal data processing based on REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 (GDPR)

Introduction

The following Terms and Conditions of Sale regulate the sale on this website "<http://www.yachts-ships.it>" (**Website**). The seller is North Coast Survey, with registered office in Via Tempio n°6 07024 La Maddalena (OT), Chamber of Commerce of Olbia, VAT number 02821240906, with fiscal code SLPDRN79R67E425F (**Company**)

Pursuant to the GDPR, the Seller shall process the personal data provided by you as indicated in this privacy policy.

Article 1. Purpose of the processing. Legal basis. Mandatory or optional nature of data provision and consequences of any refusal.

The Company shall process the personal data provided by you for the following purposes:

- a. for administrative/accounting purposes. The legal basis for the processing is Company's commitment to be compliance with a legal obligation or to take steps at the request of the data subject prior to entering into a contract, as the case may be;
- b. if you provide your explicit consent, The legal basis for the processing is your consent;
- c. to respond to your requests through the customer care service. The provision of data is purely optional. However, as the said processing is necessary in order to respond to your request, your refusal to provide the relevant data will prevent you from obtaining answer from the customer care of the Company. The legal basis for the processing is the Company's legitimate interest to perform these activities. This legitimate interest is equal to the user's interest to use the customer care service of the Website;
- d. in order to answer to your requests by email, by telephone. The provision of data is purely optional. However, as the said processing is necessary in order to respond to your request, your refusal to provide the relevant data will prevent you from obtaining answer from the customer care of the Company. The legal basis for the processing is the Company's legitimate interest to perform these activities. This legitimate interest is equal to the user's interest to receive answer by the Company.

The provision of data for the purposes set out in at Point b) is purely optional. However, as the said processing is necessary in order to enable you to register with the Website and to provide the online purchasing your refusal to provide the relevant data will prevent you from registering with the Website and from completing an online purchase.

It is understood that the Company may use your personal data to comply with legal obligations and to perform the purchase contract.

Special Categories of Personal Data. Judicial Data.

The Company does not process special categories of personal data nor judicial data.

Article 2. Methods of Processing Personal Data

The processing of your personal data will be carried out by electronic or automated means, in the manner and with the appropriate tools to ensure the security and confidentiality in accordance with the GDPR.

The information and methods of processing will be relevant and not excessive in relation to the type of services provided. Data will be managed and protected in environments where access is under constant control.

Article 3. Data Disclosure

For the purposes described in this privacy policy, the personal data provided by you may be disclosed or communicated to the following parties:

- to all those parties (including Public Authorities) that have access to the data by virtue of regulatory or administrative measures
- to companies, consultants or professionals in charge of the installation, maintenance, updating and the management of the Company's hardware and software or which the Company uses for the provision of its services
- to the company in charge of the customer care service
- to all those public and/or private parties, natural and/or legal persons (legal, administrative and tax consultancy firms), where the communication is necessary or of practical use for the correct fulfilment of contractual obligations undertaken in relation to the services provided through the Website, and of legal obligations.

Your data may be disclosed only in anonymous and aggregated form for statistical or research purposes.

Article 4. Data Controller

You may address requests relating to the processing of your personal data to both the Data Controller and the Data Protection Officer.

Article 5. Data Storage

Your personal data will be stored and processed for marketing purposes for months. At the end of this period, the Company may ask you to renew your consent to the processing of your data or to make them anonymous and keep them only for statistical or historical purposes.

For all other purposes, personal data will be stored only as long as necessary to ensure the provision of the services offered.

Article 6. Rights of the Data Subject

Pursuant to GDPR (Article 13), you have the right to:

- request access to and rectification or erasure of personal data or restriction of processing or object to their processing, in addition to the right to data portability
- withdraw consent at any time without prejudice to the lawfulness of processing based on consent given prior to the withdrawal
- lodge a complaint before a supervisory authority (for instance, the Italian Data Protection Authority).

The above-mentioned rights may be exercised by making a request to at the contacts indicated above.

Article 7. Amendments

The Company reserves the right to change this privacy policy at any time, giving suitable notice to users and ensuring in any case an adequate and similar protection of personal data. In order to view any changes, you are invited to regularly consult this privacy notice.

Cookie Policy

Pursuant to Art. 13 of Legislative Decree No 196 of 30 June 2003 Code concerning the protection of personal data and the EU General Data Protection Regulation ("GDPR")

This is to inform visitors of this website (hereinafter **Website or Site**) of the policy adopted in the field of protection of personal data underscoring its commitment and attention with regard to the protection of the privacy of visitors to the Site.

Navigating the site is free and does not require any registration, with the exception of any areas in which the user is free to specifically provide a series of data relating to access to services specifically identified. Therefore, where the visitor wishes to provide their personal data to access these additional services, he/she will be expressly informed in accordance with art. 13 of Legislative Decree June 30, 2003, n. 196 *Code concerning the protection of personal data* and the EU General Data Protection Regulation ("GDPR"), indicating the purpose and method of use of the data and the right to request at any time the data deletion or updating of the same.

Information on data protection

pursuant to and for the purposes of Legislative Decree n.196 / 2003 "*Code concerning the protection of personal data*" (hereinafter "**Code**") and the EU General Data Protection Regulation (hereafter "GDPR") provides the following information.

1. Types of personal data processed

To access the site you do not need to make any registration. However, the Website may contain sections that require registration or use of username and password (eg. to

complete a possible online purchase), or services for which require personal data (eg. newsletter, contact form, request availability, etc.).

Whenever we collect information and personal data we inform our users, according to Article 13 of the Code, of the purposes for which such data collection how they will be used. Where necessary, we will acquire the user's specific consent to their use of data. By way of example, you may be requested personal information such as your name, phone number, email address and other information that you agree to provide to use the services of the Website by filling in a specific registration form. We will use the personal data collected online for the sole purposes stated during registration.

The data relating to the connection and browsing the Website (such as notation addresses *URI-Uniform Resource Identifier* of the requested resources, time of request, the method used to submit the request to the server, the file size obtained in response, the code number indicating the status of the response from *server* (successful, error, etc.) and other parameters regarding the operating system and computer environment) are collected for the sole purpose of obtaining anonymous statistical information about the site and to check its proper operation and will be automatically deleted after a specific period. The data could be used to ascertain responsibility in case of computer crimes against the site: excluding this possibility, the data will be deleted after the expiry of the period needed to provide the services described in the Site.

With reference to the navigation data within the Site, see also item 5 on the profiling tools used by the site.

2. Optional communication of personal data

The provision of personal data is generally optional. Only in certain cases, the absence of data may make it impossible to access specific services and to fulfill your request (eg. registration is necessary to proceed to the possible purchase of products online).

3. Modes of data processing and scope of communication

The data may be handled either in electronic or printed formats. We guarantee the lawful and correct processing of personal information provided through the Site, in full compliance with current regulations, as well as the confidentiality of the data provided during registration.

Data will not be communicated or disclosed to third parties except within the limits and conditions expressly indicated each time by the user and with the authorisation of the same.

4. Links to other sites

This information is provided solely for the Site and not for other sites which may be accessed via links. We can not be held responsible for the personal information provided by users to external parties or any websites linked to this Site.

5. Profiling and / or customisation tools

The Website uses "*cookies*": these are text files that are sent from a web server (which is the computer that is running the website visited) to your browser (Internet Explorer, Mozilla Firefox, Google Chrome, Safari, etc.) and stored on your PC hard drive when you visit the site. The cookie allows the site to identify the user's PC, through the information stored on it, whenever the user reconnects to the site through the PC.

Through the use of cookies you facilitate the browsing on the Site.

Cookies **do not collect** information directly identifying the user. Cookies do not lead us to any personal information directly identifying the user (eg. name, last name) if not provided by the same. In addition, another site can not use a cookie issued by the site to access more information in the user's computer. Once saved in the computer, the cookie can be read only by the website that created it.

What types of cookies we use

Technical cookies

Cookies are used to ensure navigation and then the electronic transmission of data over the network or strictly necessary for the provision of the services provided by the Site. These cookies are usually temporary, called "*session cookies*", and they are issued by the website user's computer during browsing, but are only stored for the time duration of the navigation session itself. This means that when the user closes his/her browser the cookies are automatically deleted and disappear without being stored on the computer. They consist of random numbers generated by the server and are used to enable a safe and efficient site browsing.

Through the use of these cookies you can facilitate your browsing on the Site, such as recalling the data you provide by filling out forms on the Site (*user input cookies*), to recognize you after you logged in to the Site (authentication cookies), to customize the interface of the site based on the preferences given to gather aggregated information about the number of visitors to the site and the most visited pages (*analytics cookies*), etc. These cookies do not require the acquisition of a user's prior and expressed consent as they are strictly necessary to provide the service requested by the user of the Site (ex art. 122, paragraph 1 of the Privacy Code).

Profiling cookies

Cookies are designed to create user profiles, for example in order to send advertising messages consistent with the preferences of the user: these cookies are issued by the site on your computer when you visit the site and are also stored for the time duration of the navigation session itself, until they expire or until they are removed by you ("*permanent cookies*").

The use of such cookies requires the express consent and informed of the user (ex art. 122, paragraph 1 of the Code). When accessing the home page (or any page) of the site the user will be displaying an information banner concerning the cookies therein and will be invited to read the information provided. **If the user proceeds with navigation** (for example, clicking on the web page of the site or a link contained therein), this constitutes the user's specific consent to the use of cookies. It's also considered to be a valid consent by the user to have configured one's Internet Browser (eg. Explorer, Firefox, Chrome, Opera, Safari) in order to accept the use of cookies (ex art. 122, paragraph 2 of the Code).

We would like to inform you that your consent will be required only on your first access to the Site: later, thanks to the use of a technical cookie we will store your consent (for one year) to allow direct access to the pages of the site upon your return (subject to your right to disable / enable cookies at any time, or to delete them (see section 5.2): in this case, when you return, the site will request your consent again).

This website doesn't use any other profiling tools.

5.1 Information about the released cookies

Regarding the cookies used on the Site, we would like to provide the following information:

1) **Purpose of collection:** Cookies are used to (i) allow easier and faster navigation on the Site or for analysis / verification of statistical and anonymous information on site usage (*technical cookie*); (ii) improve the browsing experience suggesting the best products and promotions based on user's navigation (*profiling cookie*).

2) **Data collected:** Stores the following information: notation addresses *URI (Uniform Resource Identifier)* of the requested resources, time of request, the method used to submit the request to the server, the file size obtained in response, the code number indicating the status of the response from server (successful, error, etc.) and other parameters regarding the operating system and computer environment.

3) **Validity of cookies:** The Site uses session cookies (i.e. cookies that are automatically deleted when the browser is closed), possibly, for some services (*Eg. login to reserved area*), we use persistent cookies (i.e. cookies that are stored until being removed by the user), the duration of which does not exceed in any case the twelve months.

4) **Need to accept cookies:** Acceptance of cookies is not mandatory but their deactivation, while allowing navigation within the site, could make the release of certain content and functionality of the Site impossible.

5) **How to disable and delete cookies:** You can disable / enable cookies at all times.

You can disable / enable or delete cookies at any time by using the settings of your web browser. Especially, if you do not want to receive cookies, you can set your browser so that you are alerted to the presence of a cookie so that you can decide whether to accept it; you can also refuse all cookies by turning them off in your browser.

6. Rights of interested parties

Under Article 7 of the Code you have the right to obtain from the Data Processing Manager information on the processing of data, including, 1) *obtain, without delay, confirmation of the existence of personal data concerning you [...]*; 2) *obtain: a) information on the origin of personal data, the purposes and methods of processing, the logic of the processing carried out with the aid of electronic instruments, the identity of the controller or persons*

responsible (managers), subjects or categories of recipients to whom the data may be communicated or who can learn about them as managers or agents; updating, rectification or, if interested, integration of data; b) cancellation, anonymization or blocking of data in violation of law; 3) object, in whole or in part, to the processing of personal data concerning you, for purposes of commercial information or sending advertising materials or direct sales or for carrying out market research or commercial communications.

You can exercise your rights at any time by sending a notice by e-mail.

7. Applicable law

This Privacy Policy is governed by Italian law and in particular by Legislative Decree 196/2003 *Code concerning the protection of personal data* and "GDPR" which governs the processing of personal data - also held overseas - carried out by anyone who is established in Italy or through instruments located in Italy. The Code ensures that the processing of personal data will be carried out with respect for human rights, fundamental freedoms and dignity, with particular reference to privacy, personal identity and the right to protection of personal data.

8. Review clause

We reserve the right to revise, modify or simply update, in whole or in part, at our sole discretion, in any way and / or at any time, without notice, this Privacy Policy in consideration of changes to laws or regulations regarding the protection of personal data. Changes and updates to the Privacy Policy will be communicated to users on the Home Page of the site as soon as adopted and will be binding once posted on the website in this section. Please therefore regularly access this section to verify the publication of the most recent and updated Privacy Policy.
